

London Wildlife Trust

London is one of Europe's greenest major cities; almost 50% of London is green or blue space, and some 20% of this is identified to be of wildlife interest. Our city is home to a wide diversity of wildlife, including many protected species and habitats.

London Wildlife Trust looks after 40 nature reserves across Greater London and works with landowners and other groups to support the positive management of many more. Our wildlife experts work with over 1,200 volunteers to look after these sites for wildlife and people. Last year we engaged over 16,000 children in outdoor education sessions and family activities, and over 27,000 people through our events. Approximately 350,000 people visited our nature reserves.
